***General Information***

In achieving certification, the Certified Medical Laser Safety Officer (CMLSO) recognizes and assumes the responsibilities due to the practice of laser safety. As a requirement of being certified, such persons act professionally, safely, and in accordance with the Code of Professional Conduct. Each certificant has a professional and ethical obligation to practice only in those areas of laser safety in which he or she is competent. The CMLSO has a commitment to remain professionally active in the field of laser safety by maintaining certification. As the industry and technology changes, so must the knowledge of the CMLSO.

This guide is intended to help you prepare for the CMLSO examination by giving you references for you to research and study. However, use of the guide by itself will not be adequate preparation for the exam.

The references given in this guide are intended to provide the candidate with reference material related to the general topics covered in the exam. This does not mean to imply that study of these references, only, will ensure successful performance on the examination. This listing is by no means complete; the candidate may need to consult additional reports, journals, and textbooks for additional information not provided in the references below.

At the same time, not all of these references are necessary to successfully complete the examination. They are provided as a guide to the type of material that should be studied.

### ***Examination Information***

This examination is multiple choice consisting of 100 questions. Each question has a possibility of four answers. Here are a few issues to consider prior to beginning the examination:

1. Allow yourself time to answer all questions.
2. Answer the questions you are sure of first, then go back and answer the remaining ones.
3. Answer all questions even if you are unsure of the answer. An educated guess is better than no guess at all.
4. If you are unsure of an answer, your first instinct is usually the correct one.

There are eight areas of practice on the subject matter of laser safety. To assist you in understanding the subject matter, the areas of practice and what percentage they represent on the exam are provided here.

Area of Practice I – Lasers & Optics Fundamentals – 13%

Area of Practice II – Laser Tissue Interactions – 13%

Area of Practice III – Laser Beam Hazards of Eye & Skin – 16%

Area of Practice IV – Non-beam Hazards Associated with Lasers – 11%

Area of Practice V – Regulations and Standards – 15%

Area of Practice VI – Laser Hazard Classification & Controlled Areas – 13%

Area of Practice VII – Procedural Control Measures – 12%

Area of Practice VIII – Administrative Control Measures – 7%

### ***Suggested Study References***

Prior to studying for this exam, each candidate is encouraged to have recently taken or to take a medical laser safety training course online or in person.
